BRLS 2014 CASE OUTCOME MEASUREMENTS HIGHLIGHTS

BRLS staff and volunteer pro bono attorneys achieved the following outcomes for our low-income clients during 2014:

Debtor Relief and Consumer Issues

Obtained 36 bankruptcy discharges, discharging \$1,845,014 in debts while recovering \$51,553 in garnished wages.

Stopped or reduced debt collection actions against 33 clients, avoiding \$120,345 in claims and recovering \$5,194 in damages.

Avoided deficiency judgments for 7 clients, avoiding \$16,025 in claims while recovering \$500.

Quashed 39 garnishments, liens, or levies, returning \$44,667 to the clients.

Defeated 2 illegal sales contracts, recovering \$1,019 for the clients while avoiding claims of \$998.

Avoided a utility termination for 1 client.

Provided assistance with tax issue to 1 client.

Unsuccessfully represented 6 clients in consumer matters.

Assisted 21 clients with consumer matters outside of litigation.

Provided advice and counsel to 333 clients on debtor and consumer issues.

Family-Related Issues

Obtained adoptions for 2 children.

Obtained child custody orders for 36 clients while recovering \$7,840 in lump sum and \$2,619 in monthly support.

Preserved child visitation rights for 5 clients.

Obtained divorces or annulments for 348 clients, recovering some \$2,145 in monthly benefits, and avoiding \$270,000 in liabilities and \$2,000 in monthly expenses, while obtaining 110 name changes.

Obtained Separation Agreements for 7 clients, avoiding \$22,000 in liabilities.

Enforced Separation Agreements for 2 clients.

Obtained \$4,133 in equitable distribution of marital property.

Obtained guardianships for 15 incapacitated adults and prevented one unnecessary one.

Advised 11 other clients on guardianship issues.

Avoided removal of 2 children.

Established paternity for 1 child.

Obtained court protection for 20 victims of domestic violence, while recovering \$1,450 in monthly support.

Assisted 1 victim of domestic violence with safety planning.

Obtained protection from adult abuse/exploitation for 2 clients, recovering \$49,947.

Obtained, preserved, or increased child support for 16 clients worth \$5,956 monthly and an additional \$7,741 in lump sum.

Obtained reductions in child support obligations of \$834 monthly for 2 clients.

Obtained, preserved, or increased spousal support for another 5 clients, of \$1,550 in monthly support.

Acted as Guardian ad Litem for 10 children.

Assisted 9 clients with family matters outside of litigation.

Provided advice and counsel to 520 other clients on family-related issues.

Unsuccessfully represented 16 clients in family law proceedings.

Access to Health Care Issues

Obtained, preserved, or increased Medicaid benefits for 16 clients, obtaining \$240,046 in lump sum and \$17,134 in monthly financial benefit.

Provided Medicaid or long-term care planning to 6 clients.

Prevented denial of rights to 6 nursing home residents, with \$5,993 in monthly financial benefits.

Obtained \$318,971 in financial assistance on medical bills for 6 clients.

Advised 9 clients on health care issues.

Assisted 5 clients with health care matters outside of litigation.

Housing Issues

Prevented evictions for 25 families, recovering \$1,000, while successfully defeating \$13,162 in claims for charges and retaining \$2,146 in monthly rental subsidies.

Delayed eviction for 25 families, while successfully defending against \$10,512 in charges.

Avoided foreclosures for 9 clients, avoiding \$41,160 in liability.

Avoided over \$38,791 in illegal charges imposed by landlords on another 27 families while recovering \$3,608 for our clients.

Enforced rights to decent, habitable housing for 2 clients.

Enforced tenants' rights under their lease for 1 client.

Improved housing conditions for 2 clients.

Restored 1 family's access to their personal property.

Prevented denial of 2 public housing tenants' rights.

Provided non-litigation advocacy on behalf of 35 households in housing-related issues, while avoiding \$1,299 in claims.

Provided counsel and advice to 229 other clients with housing-related problems.

Unsuccessfully represented 11 clients in housing disputes.

Other Public Benefit Issues

Obtained, preserved, or increased SNAP benefits for 1 client by \$880 in lump sum and \$230 in monthly benefits.

Obtained SSI and Social Security disability benefits for 6 clients, securing \$3,993 in monthly benefits.

Obtained, preserved, or increased unemployment compensation benefits for 3 clients, with accrued benefits of \$17,311 and continuing monthly benefits of \$1,497.

Provided non-litigation advocacy on behalf of 15 households in benefit-related issues.

Provided counsel and advice to 43 other clients with public benefit issues.

Obtained \$62,000 in financial benefits for 2 clients.

Unsuccessfully represented 4 clients in public benefits proceedings.

Miscellaneous Matters

Advised 2 clients regarding education issues.

Obtained \$3,617 in back wages for 4 clients.

Advised 7 clients and provided non-litigation assistance to 1 client in employment issues.

Obtained an acquittal in delinquency case for 1 child.

Provided advice to one client regarding juvenile issue.

Preserved rights of 1 disabled client.

Advised 1 client on civil rights issue.

Obtained non-litigation advocacy for 2 clients with individual rights or disability issue.

Drafted wills for 169 clients.

Obtained restoration of driver's license for 1 client.


Drafted 218 living wills, powers of attorney, or health care proxy documents.

Advised 26 clients on wills and estates problems.

Summary

In the 661 cases involving on-going representation, we fully achieved our clients' goals in 87% of the cases, and partially achieved them in another 8%. Overall, we achieved:


- 2625 outcomes
- for 2327 clients
- that benefited 10,140 low-income people,
- including affirmative lump sum recoveries of \$397,309;
- affirmative monthly recoveries of \$26,892;
- avoidance of \$2,957,639 in lump sum debts or damages; and
- avoidance of \$21,779 in monthly obligations.









Distribution of Services by BRLS and LASRV Combined Compared to Poverty Population in 2014






























Outcome of Cases Involving On-Going Representation* 2014
