Harrisonburg Attorneys Honored for Pro Bono Work

HARRISONBURG, VA (October 15, 2015) - Five local attorneys have been recognized for their extraordinary pro bono work done on behalf of Blue Ridge Legal Services (BRLS), the Valley's non-profit legal aid society.

The individuals honored were Beth Driver of Hoover Penrod, Quinton Callahan of Clark & Bradshaw, Rachel Logan of BotkinRose, and Marshall Yoder and Matt von Schuch of Wharton Aldhizer & Weaver.

John Whitfield, BRLS executive director, presented the awards during the Harrisonburg-Rockingham Bar Association's annual Professionalism Seminar held October 7, 2015. "While the bar does a magnificent job with its pro bono work across the board, these 5 attorneys deserve special recognition for their exceptional pro bono contributions over the last year."

Since 1982, BRLS and the Harrisonburg-Rockingham Bar Association have collaborated in this pro bono referral program to provide free legal services to financially disadvantaged members in the area. Last year, the bar handled more than 300 pro bono cases for local low-income families. Over the last 2 years, more than 75% of the bar's firms and solo practitioners were involved in pro bono representation on behalf of BRLS.

Over the last three decades, this bar's pro bono program has earned state-wide and national acclaim, including the national Legal Services Corporation's Rural Pro Bono Attorneys of the Year Award in 1993, the Virginia State Bar's Lewis Powell Pro Bono Award in 1998 and 2014, the American Bar Association's prestigious Harrison Tweed Award in 1995 and a Pro Bono Service Award from the Legal Services Corporation in 2011.
