

In the 868 cases involving on-going representation, we fully achieved our clients' goals in 87% of the cases, and partially achieved them in another 8%. Overall, we achieved:

- 2833 outcomes
- for 2623 clients
- that benefited 6460 low-income people,
- including affirmative lump sum recoveries of \$829,023;
- affirmative monthly recoveries of \$40,202;
- avoidance of \$1,452,259 in lump sum debts or damages; and
- avoidance of \$6,167 in monthly obligations.
